2. The continuous service in public sector organization rendered by the candidate will be deducted from the upper age limit.
3. Disabled candidates /Special Persons shall attach proof of registration from Social Welfare Department along with Disability Certificate issued by the District Standing Medical Board.
4. Transgenders are encouraged to apply.
5. Candidates having domicile of Punjab shall only be eligible to apply.
6. These vacancies are post specific and non-transferable.
7. No TA/DA will be admissible to the candidates for test/interview
8. Candidates already working in Government/Semi Government/Autonomous Bodies shall apply through proper channel
9. The age of the candidate will be calculated on the last date of submission of application.
10. Submission of fake documents or concealment of any fact will lead to dis-qualification of the candidate.
11. Only the degree issued by the university/institute recognized by the HEC or reputed foreign university with HEC equivalence, will be considered.
12. Only short-listed candidates will be called for interview. The date & time of interview will be communicated through email/call/SMS by the department.
13. Complete Original documents along with a set of attested photocopies will be provided at the time of interview.
14. No. of vacancies can be increased/decreased at any time without any notice

1. Candidate shall apply online by visiting National Testing Service (NTS) website ([www.nts.org.pk](http://www.nts.org.pk))
2. Candidates shall submit duly filled in Application form (online), alongwith deposit slip of prescribed fee in favor of National Testing Service, cop of CNIC and two recent passport size photographs, directly to NTS through courier on the address mentioned on Application Form.
3. Test fee shall be paid through 1 Link 1 Bill Participating Banks/ATM/Internet Banking/Mobile Banking/Easy Paisa/Jazz Cash/TCS Express Counters using 20 Digits Invoice numbers generated in your fee slip. Only 1 bill invoice payment will be accepted.
4. Incomplete applications or application received after due date or closing of office hours on the last date for submission of application will not be entertained. Application completed in all respect should reach NTS till **5<sup>th</sup> January 2023**.
5. The date of written test/skill test shall be communicated to the eligible/shortlisted candidates only through NTS.

6. Candidates shall have at least 50% marks in NTS test to qualify.
7. In case of large number of candidates Qualifying NTS test, Appointing Authority reserves the right to decide upon any threshold marks ratio of candidates.
