Applications are invited from the eligible candidates having academic qualification and experience shown against each for recruitment on the following posts/vacancies lying vacant in the District and Subordinate Courts, Badin.

Procedure to submit application

1. All the candidates at S.No. 1 are required to fill "Online Job Application Form" and deposit challan/slip of Rs.800/- (Rupees Eight Hundred only) from www.nts.org.pk. Fee of Rs.800/- may be deposited via 1 link 1 Bill Participating Banks/ATM/Internet Banking/Mobile banking/Easy paisa/Jazz cash/TCS Express Counter.
2. The Candidates apply for the post at S.No.1 are required to fill online application form, and do not required to send hard copy of the form and challan to NTS. Candidate must keep the copy of the application form for any further communication.
3. No application for the post at S.No. 1 will be received by hand.
4. For the posts mentioned at S.No.2 to 6, candidates are required to send their applications alongwith attested copies of required testimonials, educations certificates, Character certificate, Domicile/PRC, CNIC, two recent passport size photographs and NOC (in case of Government servant) by post or by hand, addressed to "District and Sessions Judge, Badin before last date.
5. The last date of submission of application for all posts will be 16th February, 2026.
6. Application received in any manner after due date will not be considered/entertained.
7. Candidate(s) applying for more than one post should apply separately for each post.
8. The list of eligible and ineligible candidates will be uploaded on NTS website and this Court website and notice board for inviting objections, if any.
9. Special quota shall be observed as per rules/policy, where applicable (disabled and monitories etc).
10. Candidate with disability are required to submit CNIC having wheelchair logo issued by NADRA and valid disability Certificate. Disability quota of five percent will be strictly observed and considered as provided in section 5 of the Sindh Civil Servants Act, 1973.
11. Candidate(s) applying against reserved quota should specify in the application.
12. Female candidates shall also be provided equal opportunity to participate.

13. Government servant should apply through proper channel.
14. In case of Government servant who has served in connection with the affairs of the Federation or the province of Sindh for a period not less than 03(three) years, the upper age limit shall be 30 (thirty) years as per Sindh Judicial Staff Services Rule-1994.
15. Overage candidates if qualified test/interview and selected for appointment on the basis of experience, qualification and skills, the individual cases of successful candidates would be submitted to the High Court of Sindh for relaxation in their upper age limit and approval.
16. For the posts mentioned at S.No.1, the candidates obtain 40% marks in the initial tests shall be called for skilled test by NTS.
17. Dates for written (skilled tests) and result of candidate from S.No.01 will be announced by "NTS" Testing Service on their official Website. The list of successful candidates will be affixed on the notice board of District and Session Court Badin with date for their interview.
18. For the post at S.No.2 to 6, the interview/test will be conducted by the Departmental Selection Committee (DSC) of this office.
19. All the candidates shall mention their Mobile/Contact numbers and complete postal address for any further communication.
20. Candidates, at the time of interview, should bring their original documents with application form.
21. Number of vacancies may be increased or decreased.
22. Decision of the Departmental Selection Committee (DSC) of this office shall be final.
23. Incomplete applications or those arrived after the due date will not be entertained and will be rejected without assigning any reason.
24. No TA and DA will be paid for appearing in Test/Interview.
25. ANY EXTERNAL INFLUENCE FOR SELECTION WILL LEAD TO DISQUALIFICATION FOR THE POST APPLIED FOR AND THE DECISION OF THE DEPARTMENTAL SELECTION COMMITTEE (DSC) OF THIS COURT SHALL BE FINAL.
